# 7. Superintendent's Report

Welcome to our December Board of Education meeting.

As many of you know we began a new phonics program in September called Fundations. I have been around to visit the program in action and I am impressed by the students' engagement and participation. Recently our kindergarten teachers from Rhame and Centre, who are involved with this new program, visited the Malverne Schools where it has been in use for a few years. It was a great professional development opportunity for our teachers to see the program in action and learn from other teachers who have experience with the program.

At Rhame Avenue the 4<sup>th</sup> grade students demonstrated their learning of Indian culture by presenting a POW-WOW. Also at Rhame Avenue, the students participated in Star Lab, which connects to their science curriculum.

At Centre Avenue they held a decade day where students came to school dressed in period costumes of that decade to gain an understanding of the culture of that time.

Rhame students in grade 4 are reading the novel, *Skylark* and the grade 6 students are reading *Crash*. I had an opportunity to read *Crash* with the students at Centre Avenue last year and if your child is involved in reading this book I recommend it to you as it creates opportunities to talk to your children about things that are important in life.

At Centre Avenue Grade 5 is reading *Bridge to Terabithia* and students in Grade 4 are reading individual novels for book reports.

At the secondary school the reading class finished the book *Twilight* and will be taking a field trip this week to see the movie and make a comparison between the author's words and the screenwriter's.

Our evening high school, ALPSS, had a Thanksgiving feast on November 25<sup>th</sup>. The students learned how to prepare a meal as though they were working in a restaurant. They needed to create a plan, budget for the meal, organize the work involved and prepare the food. They invited and served members of their families.

We've begun the transition of our 6<sup>th</sup> grade students to the high school. Mr. O'Driscoll, our middle school guidance counselor, has been visiting the elementary schools and meeting with the students. In addition, Mrs. Singer has arranged for the 6<sup>th</sup> grade students to come to the secondary school on Tuesday and participate in an assembly with the 7<sup>th</sup> and 8<sup>th</sup> grade students. This assembly will include a speaker from the Holocaust Memorial and Tolerance Center of Nassau County. This connects to our social studies curriculum for all three grade levels.

Good news from our Athletics program—the following Varsity teams achieved a 90.0% average for the required players to receive the team scholar award. Girls Soccer, Boys Cross Country, Girls Cross Country, and Volleyball. Also, the Girls volleyball team had two members named to the all State Team: Jalisa Barnes-1<sup>st</sup> team and Chrissy Feil-2<sup>nd</sup> Team. In addition, Monica Mielinis and Brice Reynolds received the Nassau Zone Outstanding Physical Education Students of the Year Award. Congratulations to our athletes.

Also from the Athletics Department, the Tip Off Night Program is now available on the district website under High School Athletics.

Our fine arts program continues to flourish. Last Thursday evening was the elementary holiday concert. It was wonderful. This Thursday is the secondary school holiday concert. It is always a relaxing and enjoyable experience. Everyone is invited to attend.

Also from fine arts, last month I mentioned that the PTA Reflections contest was underway. We had a total of 128 students participate.

SEL words this month are: unique, envious, anxiety, apprehension, guilty, humble, remorse, elation.

There will be some work completed over the holiday break. This will include removing the carpet in the PPS office, which also involves asbestos removal. Also during the break seven Smartboards will be installed: 1 at each of the elementary schools, one in the middle school wing and four in high school classrooms. Five of the Smartboards are from a grant from Assemblyman Bob Barra.

In addition various locations will be painted.

We had two Nassau TRACT Grant winners, both from Rhame Avenue School. Mrs. Hiller, grade 1, received a \$500 grant for science materials and Mrs. Smith, school psychologist received \$538 to facilitate a collegial circle on positive behavioral support in the elementary school. The book that the staff will be reading together is *Positive Discipline in the classroom: Developing Mutual Respect, Cooperation and Responsibility in your Classroom*, by Jane Nelson.

Our Its academic teams, varsity and JV won their matches against West Hempstead last week. Each school is conducting a toy drive for the holidays.

On December 8<sup>th</sup> the students from our elementary schools participated in the annual Make a Soldier Smile event which is sponsored by Dees' Nursery. This project sends trees to the troops in Iraq.

Two pieces of information to follow-up:

Last month when I announced the results of some of the high school teams I was asked why I don't announce the middle school teams. Mr. Vulpis tells me that we do not keep score for those teams.

Also, in October I shared the parameters for a Blue Ribbon School. Centre Avenue has been invited to apply for the award based on last year's Grade 6 scores in ELA and math. The process is underway and we will know the results in August 2009.
