7. Superintendent's Report

Thank you to everyone who has been offering assistance to re-open our schools.

Today we opened school for all K-6 students. They reported to Centre Avenue and we have combined the buildings until Rhame Avenue is ready for the students to return. Today at Centre was about helping the students make sense about what happened to their homes, their community and their schools. Students had an opportunity to talk about their experiences, and hear the experiences of their classmates. Our social workers and psychologists will be conducting voluntary discussion groups for students demonstrating the need for more social emotional support.

Here is the update on Rhame Avenue School--As you are aware the entire first floor of the building has been affected from the flooding. All of the flooring from the first floor was removed and the drying process is moving along. The moisture content in the slab is still extremely high and we are constantly monitoring it. Once the moisture level drops to an acceptable level, floor tile installation will immediately begin. The boilers, pumps, motors, controls, electrical wiring are all in the process of being evaluated. Temporary boiler installation is in process in order to restore heat to the building to prevent further damage. The switch gear at Rhame was not under water. We are waiting for power to be restored to check the electric there.

At the High School, the Small gym flooring and wall padding have been removed. Drying is in process. In the Large Gym flooring and wall padding have been removed. Drying is in process. All miscellaneous offices, locker rooms, hallways have had the initial cleaning. All vinyl floor base and any saturated wallboard has been removed and drying is in process.

In the Auditorium all water damaged seating has been removed. Stage flooring has been removed and the space is being dried out.

The electrical switchgear has extensive water damage with the corrosion process starting on all vital internal components. Cleaning of the interior panels has begun and multiple parts have been ordered. An electrical engineer came to the school today to consult with the electrical contractor as to the best way to proceed with the electrical related repairs in order for the power to safely be restored to the building. Once power can be restored to the switch gear the building can then be systematically checked, tested and evaluated as to what may or may not need replacement and or repair.

Here is the plan for our secondary students. On Wednesday they will come to the high school during assigned timeframes. Mr. Spero will be sending out an electronic message and it will also be posted on the website. For those of you who have Facebook it would be appreciated it you would share the information you receive using this technology.

The high school crisis management team will be available in the library on Wednesday during the time that students are cleaning out their lockers. The team will also be available when the students arrive at their new temporary locations in Baldwin. Social emotional services will be available to the students on a daily basis.

7-12 students will be bussed to school beginning on Thursday. There will be two pick-up locations. Students living south of Main Street will report to the Rhame Avenue parking lot. Students living north of Main Street will report to the high school front oval. We ask for your patience as we work out the details for transportation. Next week we will evaluate the transportation plan and make the necessary modifications. Students may begin boarding the buses at 6:45 am and the buses will depart at 7:00. Classes will begin at 7:45. Hall passing time has been reduced so that students may board buses and return to East Rockaway by 3:00.

The central office staff has been relocated to BOCES on Merrick Avenue in Westbury. This includes the Superintendent's office, Mrs. Tannenbaum, Dr. Lo Verde and Mr. Piccarella. The phone extensions do remain the same.

The November calendar has had many changes. The Financial Aid program for tomorrow has been cancelled as well as Thursday's ERHS PTA meeting. Friday night's Rhame Avenue Slumber party has been cancelled and the Centre Avenue PTA meeting, scheduled for tomorrow night, has been postponed and combined with the Rhame Avenue PTA meeting on Tuesday, November 27th at Centre Avenue.

Make-up days and calendar.

There were nine scheduled instructional days lost for elementary students due to the storm and eleven for the secondary students. We are looking at the calendar to identify the exact days. We are also waiting to see if any of those days will be waived by the state. The obvious days are April 1st and 2nd as listed on the calendar as possible snow make-up days and the other days are the four vacation days from the February break. I will work with the teachers association to identify the remaining days that may have to been made up.

There are lots of well deserved thanks. Thanks to the community for helping each other. I am especially proud to be a part of this community.

<u>Kristin Ochtera</u> – I had the opportunity to speak to the staff on opening day. Last week I asked them the same question. Go home and think about what we did...how did we move forward? Do your very best every day and it will get better.
