2014-2015 Proposed School Budget

Tonight the Board of Education approved the school budget the 2014-2015. The budget to budget increase is 1.23%, the lowest increase in more than 10 years. 1.73% is the tax levy law-compliant increase. Our proposed budget maintains all current academic and extracurricular programs, adds additional AP and college-level courses, and provides for enhancements in our elementary reading support program. Our budget hearing presentation will take place on Tuesday, May 13th at the ERHS auditorium at 7:00 PM. Elementary Schools

- Centre and Rhame Avenue Schools completed NYS ELA testing April 1, 2, and 3.
- Math testing is scheduled for April 30, May 1, 2.
- Kindergarten Screening is in progress. If you know of a child that will be 5 years old on or before December 1st please have them call the registrar at 887-8300 ext. 440.
- Centre Avenue and Rhame Avenue 6th graders attended Greenkill Environmental overnight experience on April 9-11 and had a successful trip learning about pond ecology, forest ecology, orienteering, and team building. Rock wall climbing and canoeing were explored as well.
- East Rockaway Jr./Sr. High School Guidance Counselor, Jim O'Driscoll, visited our 6th graders on April 23rd and 24th to bridge the transition from 6th grade to the Junior High School.
- Reading teachers, Lorraine Donlon and Ashley Tener, organized Centre Avenues
 March Reading Madness. Students competed by grade level to read the most minutes
 during the month of March. Ms. Lyons' 4th grade class logged 11,710 minutes as the
 overall classroom winners.
- Centre Avenue School is participating in Assemblyman's Brian Curran's Flag Day essay contest in grades K-5. Winners will be recognized on Sunday, June 8th at Greis Park.
- The Centre Avenue class of 2013 donated two paper cutters, a paper shredder, an IPod dock for the Physical Education program and 4 CB radios to improve safety during the lunch program.
- The Centre Avenue PTA has curriculum enhancement funds to supplement classroom teaching. Centre Avenue kindergarten teachers used these funds to purchase an incubator. Twelve chicks were hatched to the children's amazement. Integrated curriculum units centered on the chick hatching project.
- Rhame Avenue is piloting a dog therapy program in our special classes. Tootsie, the miniature Labradoodle, is certified through Therapy Dogs International (TDI.org) and visits children in a variety of settings ranging from schools to hospitals. She is a hypoallergenic, non-shedding dog. When visiting children at school, she serves as a Tail Waggin' Tutor. Children sit with her, either individually or in a small group, as they read aloud. For struggling readers or socially shy children, Tootsie offers a safe audience without fear of judgment. Over time, students build more confidence as they practice reading in a relaxed atmosphere.
 - The Rhame Avenue PTA held their annual Flight Night on Wednesday, March 12th. Students form 3rd and 4th grade came together to learn how to make paper

Middle school students and the teachers participated in the annual Long Island Language Teachers poster contest. The theme of this year's contest was "Unmask Cultures: Be A Polyglot." The department reviewed all student poster entries and submitted five students in the regional contest.
