BE IT RESOLVED, that the Board of Education of the East Rockaway School District hereby adopts the coverage provided by §18 of the New York State Public Officers law for the following job titles: members of the board of education, the superintendent of schools, the assistant superintendent for finance and operations, the director of pupil personnel services, the director of curriculum and technology and the director of facilities. The adoption of this provision is intended to supplement and not supplant the protection available to such employees by virtue of already existing statutory provisions or other sources. Such coverage shall include, but not be limited to, being called to testify as a witness or to answer questions concerning their acts or omissions within the scope of their office, agency or employment before a Grand Jury, the Office of the District Attorney, or other law enforcement official. Nothing herein contained shall be construed to authorize or require defense or indemnification to a member of the board of education, the superintendent of schools, the assistant superintendent for finance and operations, the director of pupil personnel services, the director of curriculum and technology and the director of facilities, who has been identified as a defendant in a pending criminal prosecution, or where such individual or the school district has reason to believe that such individual is a target in a criminal investigation or prosecution by the Office of the District Attorney or other law enforcement entity. This benefit shall not be available to and shall not cover any employee serving in any of the job titles listed herein who is represented for collective bargaining purposes by a duly designated collective bargaining agent unless and until such coverage is negotiated with the collective bargaining agent representing said employee. The superintendent or her designee shall take steps necessary to obtain insurance protection against the potential liability to the district arising out of the adoption of this provision.

WHEREAS, based on the recommendation of the District's Architect and the Superintendent of Schools, it is essential to undertake certain work in order to implement such preventative measures, as set forth in greater detail in the draft Hazard Mitigation Proposals developed by FEMA for the East Rockaway High School and Rhame Avenue Elementary School ("HMP"); now, therefore,

BE IT RESOLVED that the Board of Education of the East Rockaway Union Free School District hereby declares that the scope of work contained in the draft HMPs is essential for the protection of the health and safety of students and staff and for the protection and preservation of the District's property, and that such work constitutes an ordinary contingent expense of the District; and be it further

RESOLVED, that the Board of Education hereby approves the draft HMPs, subject to final revisions as recommended by the District's Architect and approved by FEMA, and authorizes and directs the Superintendent of Schools to take such steps reasonably

necessary or appropriate to implement the draft HMPs in accordance with this resolution, and authorizes the Board President to execute any and all contracts for public work and professional services or the purchase of supplies, material or equipment in connection therewith; and be it further

RESOLVED, that the Board of Education hereby authorizes the District to expend an amount not to exceed \$5,500,000 in connection with said HMPs, 90% of which shall be funded by FEMA grants with the balance to be funded from available sources as permitted by law.
