1. The meeting was called to order by Patti Nicoletti at 7:00 p.m. Kristin Ochtera led the Pledge of Allegiance.

Board President Patti Nicoletti welcomed everyone to the meeting. She stated that tonight there will be three presentations: DECA, art and music awards, and tenure recognitions. There will be a brief intermission for refreshments and then the regular board meeting will begin. She turned the meeting over to Ms. Ruiz who welcomed everyone. Ms. Ruiz was happy to see a full audience and announced that we will be recognizing both students and staff tonight.

Ms. Ruiz spoke about the DECA club. This inaugural business club was launched this school year and students have already advanced to the New York State level. Ms. Ruiz introduced Mr. DeTommaso who spoke on behalf of DECA Club advisors, Mr. Lores and Ms. Robbins who were not able to attend. Mr. DeTommaso thanked Ms. Ruiz, the Board of Education and staff for recognizing and supporting this new club. He spoke about the purpose of this business club. He then introduced James Tierney, DECA Club President who shared his personal experiences. Connor Irvine also spoke about his personal experiences. A video presentation was shown recapping the events that took place during the year. Mr. Tierney thanked the Board of Education for supporting this business program. Mr. DeTommaso thanked the students for a great job. Ms. Ruiz also thanked the students for an outstanding job and was impressed with what was shared this evening. She looks forward to next year's accomplishments.

Ms. Ruiz introduced Mr. Schloen who spoke about the music and art awards being presented tonight. Mr. Schloen introduced music teachers, Ms. Mihalik, Mr. Ceglio, Mrs. Lalama, Ms. Silver, and Ms. Weill. The teachers introduced elementary and high school students who were selected to participate in various performances. Students were awarded certificates for NYSSMA, All County Honors Ensembles, the Long Island String Festival Association, and All-State. The

students were all called to the stage with their certificates and a photo was taken.

Mr. Schloen then introduced the art teachers, Ms. Brody, Ms. Hirten, and Ms. Cabasso. The art teachers spoke about the art shows, exhibits and competitions the students have participated in. The students were called up, presented with certificates and a photo was taken. Elementary and high school students participated in: New York State School Board Association Exhibit, Colors of Long Island, The NYSATA Legislative Exhibit, The Art Supervisors Association (ASA), Art in the Heart, NYS Martin Luther King Jr. Contest and Exhibit, NYSATA Portfolio Project, NYIT Exhibit, LIU Advanced Visions 13 High School Artists for Excellence, Scholastic Art, Art Guild-Port Washington, Nassau Community College Student Art Exhibit, Heckscher Best of Long Island, Rockville Centre Art Guild, and Congressional Art Competition.

Ms. Ruiz said she was amazed, impressed and grateful to the Art and Music Departments. She thanked the art teachers for an outstanding art program. Many of the students' works were on display at the Art Show during the budget vote and at the Village Art Show held on the waterfront this past weekend. She congratulated the students on their achievements.

Ms. Ruiz stated that tonight we are celebrating the wonderful work our staff does and granting tenure to nine staff members. She spoke about the requirements and process that is involved when granting tenure. The first educator being recommended for tenure was Laura Guggino-Hastings, Pupil Personnel Director. Ms. Ruiz spoke about her background and accomplishments, and recommended her tenure to the Board of Education. Ms. Guggino-Hastings thanked the Board for recognizing her efforts for tenure.

Ms. Guggino-Hastings then spoke about the background and accomplishments of elementary teacher Erin Kennedy, who had previously been granted tenure, and Dawn McCabe, social worker. She recommended their tenure to the Board of Education and the Superintendent.
